1. SELECTION CRITERIA 1.2. Artworks submitted should demonstrate a belief that cultural and creative expression can be used as a means to effect deep and lasting social change. 1.3. Entries should demonstrate a relationship to the theme of the award, 'Art for Social Change'. 1.4. The Shortlist Selection Panel will consist of three Incinerator Gallery staff and one external panellist from an Australian contemporary arts organisation, 1.5. The Shortlist Selection Panel will grade artworks independently, based on the response to the theme 'art for social change.' Entries will be critiqued on communication, quality, and content. 1.6. The Entry will also be considered for artistic and ethical merit, achievability of installation and additional support material supplied by the artist. 1.7. Only shortlisted artworks will be eligible for Exhibition and Incinerator Art Award prizes.

2. ENTRIES 2.1. Entries will only be accepted via the online form before midnight 30 April 2023. Only online submissions will be accepted. 2.2. Artists may only submit one artwork per entry. 2.3. All information included in the entry must be true. Incorrect information may make entries ineligible and the artist may be held responsible for any loss caused to the organiser. 2.4. The fee is \$30 per entry. This fee is payable at the time of the entry being submitted, and is non-refundable. 3. ELIGIBILITY 3.1. Artists must be 18 years of age or older to enter. 3.2. Artworks must be complete and ready to display at the time of entry. 3.3. Artworks must have been created within the last five years. 3.4. The Award is open to artists currently living and working in Australia. 3.5. Artworks must not have won other art prizes or awards. 3.6. Moonee Valley City Council employees, volunteers, and councillors, or their family members, relatives or household members are ineligible to enter.
